REQUIREMENTS AND POLICIES FOR PARTICIPATING IN HRC INTERNATIONAL GRAND HUNTS

THE PREMIUM REQUIRES THAT YOU HAVE READ AND UNDERSTAND THE FOLLOWING INFORMATION:

ENTRY FORMS: must be made online at www.HRCEntry.com. The participant will have until **12 noon CST August 27, 2025** to enter to be eligible for entry in this Grand Hunt.

IN ORDER TO ENTER ONLINE:

- HRC Membership number for both the Owner(s) and the Handler must be valid as of the entry deadline date.
- A valid UKC Registration at time of entry deadline.
- Only one (1) Handler – the individual actually handling the dog.
- Electronic acceptance of the Release of Liability and certifying the immunizations of the dog are current and appropriate.
- Acknowledgment and acceptance of the terms and conditions of refund policies.

CONDITIONAL ENTRY: A Conditional entry may be received on or before 12 noon CST August 27, 2025 without a dog acquiring the necessary 100 HRCH points to enter the Grand event. It is the **OWNER'S** responsibility to ensure that his/her dog is eligible to be entered. Any dog entered in the Grand that does not have 100 points **PRIOR** to the Grand, will not receive Championship Points or Grand Pass credit, if the dog passes the Grand. Please contact the Secretary to remove the conditional entry from the Grand Hunt. Entry fee less \$200 scratch fee will be refunded to the Owner. **Plaque fees are not refundable.**

ELIGIBILITY - It is the owner's responsibility to ensure that:

- 1) His/her dog is eligible to be entered (has earned HRCH);
- 2) The Owner listed is the Registered Owner on record with UKC; and
- 3) Both the Owner and Handler have provided HRC Membership numbers and both must be **valid as of the entry deadline date of August 27, 2025.**

ANY OF THE ABOVE ITEMS LISTED IN ERROR SHALL PREVENT THE AWARDING OF POINTS AT THE CONCLUSION OF THE EVENT.

LOGISTICS: Handlers choosing to travel in the same vehicle must make their own logistical arrangements in order for each handler to be at the appropriate series when it is their turn to run.

FLIGHTS/RUNNING ORDER: Handlers MAY request being in a Flight with someone else and all reasonable attempts will be made to honor the request. Handlers sequence preference of running their dogs will NOT be accepted. **No changes will be made after the deadline date.**

SCRATCHES: Scratches no longer require a Veterinarian's Certificate (Illness, Injury or Bitch in Season). **The Scratch fee is \$200.00 after the close of entries.** This fee is not imposed on scratches with replacement dogs. Scratches prior to the close of the entries are fully refundable less any processing fees. A dog that has been scratched can only be replaced from that handler's list of dogs. To replace the scratched dog, the handler/owner must fill out the form (on the next page) and submit to the Secretary. Plaque fees **are not** refundable.

Handlers - Check-In and Meeting: Friday, October 17, 2025

Handler Check-in and Meeting – times will be announced at a later time.
Bird ordering information will be posted on social media at a later date.
Campsites are mostly closed this time of year in this location. You may want to call and make plans ahead of time if you are going to be using campsites.

Handlers must wear Camo/Hunting Attire

COURSES: Ducks, Chukars/Pheasants will be used in all hunts.

PRIZES: 40 United Kennel Club Championship Points

ENTRY FEE: \$400.00

PLAQUES: \$42.00 Plaques of participation in the Grand Hunt are available by pre-order only and will be mailed directly to owner/handler by the company. The Grand is not responsible for the plaques. They are ordered through Entry Express. **Fees are nonrefundable for plaques ordered.**
