SECTION III, Page 63, SEASONED HUNT TESTS / HUNTING TEST

CURRENT RULE WORDING:

The hunting test must duplicate actual hunting conditions. Practical hunting distances must be used in all Seasoned hunting retriever tests. Dead pheasants, pigeons, ducks or other game birds must be used for all hunting tests, except for shot flyers or Upland game tests, to gain championship points.

PROPOSED CHANGE:

The hunting test must duplicate actual hunting conditions. Practical hunting distances must be used in all Seasoned hunting retriever tests. Dead pheasants, pigeons, ducks, other game birds, OR SIMULATED MALLARD DRAKE (size/color specific) must be used for all hunting tests except for shot flyers or Upland game tests, to gain championship points.

JUSTIFICATION: *Game Bird Availability / Game Bird Cost / Longevity of the Sport*

This proposal is an opportunity to get out in front of a growing problem and plan for the continuation of our sport, our clubs and ensure the health / wellness of our Retrievers and our people.

Game birds are becoming harder and harder to obtain and extremely expensive. Currently if a club plans on using Ducks, they can expect to pay \$20+ per bird. Pheasant and Chucker pricing / availability is not much better.

Highly Pathogenic Avian Influenza (HPAI) and Low Pathogenic Avian Influenza

It is of no surprise that the Avian (bird) Flu continues to impact and threaten wild bird populations as well as game bird farmers and operations. In efforts to slow or stop the spread of deadly outbreaks among the wild and farm raised populations, many of the state wildlife agencies and disease control centers have begun to implement stronger requirements / regulations of the farm raised birds and the state / state transportation. These new regulations are seen as a root cause on the reduction of game bird operators as well as the cost and availability of the game birds. Clubs are already reporting availability is impacting their ability to hold hunt test. You must believe that the individual states Wildlife Departments and US Wildlife Department, Department of Agriculture and CDC are looking into mitigating the risk of spreading by imposing stringent regulations on Game Bird operations and the interstate transportation. Up to halting all interstate transportation of any live gamebirds without health clearances. A positive flu test currently requires the destruction of all live birds on the premises.

In Essence - we are 1 bird disaster away from losing any given HT event.
