# Change to Charter

Added editing period was at the national meeting prior to the national meeting start time and submission of July 31 of each year.

Separation of what is a rule and what is a policy. This is showing up in new rule book. Electronic ballots will be the process of voting for the 2020 rule changes.

- 1. Quartering at the grand-remove
- 2. Upland tracking out of seasoned
- 3. Duplicate cripples, remove from rulebook
- 4. Grand Removed the verbiage that the dog will be released by the judges.
- 5. Grand steadiness at the line will be changed to all times
- 6. Cripple removed from seasoned
- 7. Upland tracking out of finished
- 8. Seasoned remove upland completely but leaves walk up
- 9. Started- sending per bird as resending
- 10. Started- steady remove the word "not"
- 11. Remove tracking out of Upland
- 12. Removing tracking out of finished
- 13. Diversion bird, removed from seasoned test.
- 14. Add pointing portion to the upland test.
- 15. Test dog grand dog can't be used as test dog at finished level
- 16. Removed the dry shot for blind in seasoned
- 17. Fail for switch in seasoned diversion
- 18. Completely remove all upland verbiage from Finished
- 19. Uncontrolled break, started, seasoned, immediate failure
- 20. Upland increase distance that a gunners would be allowed to shoot
- 21. Upland gunners cannot shoot until after the handler shoots.

#### **Electronic ballots**
