- CALL TO ORDER: The annual meeting of the Hunting Retriever Club, Inc. (HRC) was called to order at 8:07 a.m. on June 12th 2021 by President, Glenn Dye. Glenn welcomed everyone and asked Mike Botts to open the meeting with a word of prayer.
- II. ROLL CALL: The Executive Committee (EC) made up of Glenn Dye, President, Jack Gravely, Vice President, Elaine Mitchell, Secretary and Sarah Krause, Treasurer was present at the meeting. Joy Freeland was present as Parliamentarian.

Roll call – Elaine Mitchell, Secretary called the roll. 118 of 143 clubs were represented either in person or by proxy. With the 4 EC members and 118 clubs, a total of 122 votes were available and a quorum was satisfied.

Among the ideas presented was to try to create mock judging opportunities either at the seminars or at non-sanctioned club trials to create the opportunity to discuss how specific scenarios would be judged. Ken noted that there were several other ideas suggested; that some may work and some may not but that important part is that we try and that keep moving forward with what works.

Sponsors Committee Report - Lori Greer, Committee Chair

Royce Meynburg addressed the group on Lori's behalf. Royce commented on what a pleasure it had been to serve on the Sponsorship Committee the last few years and how much change that they had seen. HRC is a great organization and sponsors want to be a part of it. We have people seeking us out rather than having to seek out sponsors. Royce recognized Legacy sponsors Purina and Garmin along with our other sponsors and thanked them for their continued support.

The committee has a flyer available to clubs (copy attached) that shows 2021 sponsors and the level of support that they offer. Royce thanked Freddy King for providing duck calls for our youth camps. The first of those will be presented at the youth camp in Texas immediately following the Grand.

Members were encouraged to follow the HRC International Grand page on Facebook and Instagram as the official source of HRC sponsors on social media.

Call for questions:

Mark Fries, Northeast TX HRC: What can we do on a club level to get (banners and) materials to make sure we are giving our sponsors the support they deserve at weekend events. There was extensive discussion among the group about the logistical and economic issues associated with providing and maintaining current banners for 140+ clubs. The issue was tabled with a request from President Dye for the Sponsor Committee and the PR Committee to work together in the coming months to bring a proposal to the meeting next year.

<u>Ken Reinert, Fox River Valley, HRC</u>: Just a point of interest really. We talk a lot about social media and electronic posting but we need to remember that a lot of our members do not use social media. Maybe we should consider posting a complete list of sponsors in the magazine that could be easily edited with each publication to accommodate changes.

Margo Ellis, Treasure State HRC: A suggestion might be that the clubs could have small banners made with sponsors if we could be given the data to print out at say Staples. Those banners are not that expensive and you could post at each of your flights like a site sponsor. The question is how do we get current sponsor info? Your PR people are definitely going to be your resource. (NOTE: this was later discussed in detail and clubs printing their own banners is NOT an option due to logo copyright issues and sponsor contracts).

Kyle expressed appreciation to the EC for bringing the committee to the meeting since this is not a PR year. They missed our meeting when we had to cancel last year. Twelve of eighteen PR reps were present for the meeting. Kyle introduced the new PR reps added since the last meeting: Carol Caito out of region 4/4A, Erica Wilson out of Region 1, and Deb Eckardt out of 8B.

The committee spent some time going over Social Media in their meeting. Every region has a Facebook page and we are working to keep them updated and informative. Any content on those pages needs to HRC related only. We want to promote local club activities. We want to strictly keep all for sale ads off. Pictures need to be in the HRC spirit and we want to avoid material that is in conflict with our sponsors.

The committee also talked about helping the sponsor committee get the word out about sponsors. We hear it all the time, club members/officers don't know who the sponsors are. The sponsor committee has twice sent over new and updated sponsor forms. All the PR reps sent that out to their contacts at the local clubs but it doesn't reach the members. We are going to start an effort to put pictures, hashtags of our sponsors on those Facebook pages.

Kyle agreed that banners have always been a challenge. At one point there was group that had banners and would take them around to events but they were getting stolen overnight. And the sponsors change so frequently. I don't think most of our sponsors would want to be on a banner with another sponsor. Then there is the issue of numbers. Getting them and keeping them current for 143 clubs is difficult.

Glenn Dye, HRC President: Called the meeting to order. Regarding the earlier discussion, clubs making their own banner is not something we can do. The banners have logos on them that companies have registered. We can't just use those logos willy-nilly. We have been talking about banners for a couple of years and nobody's come up with a solution. How are we going to do this? We want to showcase our sponsors. We want to do it at a hunt. But what I challenged them with, I've got a feeling they're going to come back 12 months from now and not really have a good solution. Doing all this, it's not an easy task. 140 plus clubs, times 10 sponsors = 1400 banners. Who is going to keep up with them? How are we going make sure they stay current? It won't be easy to do that.

Kyle Krause, PR Committee Chair: Your National Treasurer just came up with an idea, just texted me with an idea of something we can do for the clubs. If HRC is willing to do an HRC only banner that just says HRC, the gun logo on it, put a QR code on it. That QR code can go directly to a page on our website that Tammy keeps updated with sponsor information.

Running Rules Committee - Todd Tharp

Todd Tharp, Committee Chair presented the report. He summarized Running Rule Change proposals for this voting cycle that will be sent to the clubs for consideration in October. The Board Members will receive a complete copy of the proposals with their ballots.

- 1. Require triple marks in the finished level instead of having the option to throw double marks.
- 2. In Seasoned, pertains to hunt area not overlapping nor can a retriever be expected to run through one hunt area to proceed to another one.
- 3. In Finished, pertains to hunt area not overlapping nor can a retriever be expected to run through one hunt area to proceed to another one.
- 4. Remove the cripple retrieve from the seasoned test.
- 5. Remove 3-4 references in the rulebook where it says the dog will be released on the judge's signal.
- 6. In seasoned, remove reference to Tracking & Quartering that was overlooked in the last revision.
- 7. Clarify the honor dog must sit or stand, cannot lay down on the honor.
- 8. Remove requirement to shoot the blind in Seasoned.
- 9. Remove diversionary bird from Seasoned.
- 10. Add verbiage that clarifies when the honor dog will be excused so that the rulebook matches current practice.

With the approval of Parliamentarian Joy, Freeland Todd Tharp returned to the podium with a proposal to make a change to the Running Rules Committee Charter. Todd proposed that the wording in their charter be changed to accept a simple majority vote on proposed running rules changes during the bi-annual ballot process. The current charter requires that any proposed change to the HRC Running Rules not resolved with a 2/3's majority during the balloting process be referred to the floor at the BOD meeting for discussion and a second vote. Once it reaches the BOD meeting it can be resolved with a simple majority.

Todd indicated that he had reviewed the ballots for the past 6 voting cycles (12 years) and that there was no benefit in reviewing the proposals a second time. Of the ballots that he reviewed, the final outcome for those proposals that did not pass or fail by a 2/3's majority and had to be brought to the BOD meeting for resolution was no different than if we had accepted the club's original vote with a simple majority.

Todd Tharp proposed a reorganization of the HRC Rulebook to be implemented at the next printing that would divide the book into 3 sections: 1 Running Rules, 2 HRC Policy, 3 UKC Policy. The reorganization would not change anything thing in rulebook except to eliminate duplications where information is repeated verbatim from one section to another (i.e. we say the exact same thing in Started, Seasoned &

Finished) and to organize the book in a way that makes it easier to find the information you are looking for and to distinguish between rules/policy.

HRC Foundation - Glen Stelly

We have heard a lot about HRC's growth today. 144 clubs, 8449 members, 8 new clubs just since January 2021. Even with Covid, entries are up, the number of events are up. We have talked a lot about the judge's pool. Jack said he didn't think the judges pool is really decreasing that much. We have just added so many more clubs/tests that there is just more demand. He stressed getting more people involved. We cannot sustain the growth we are seeing without getting some more judges.

He thanked the sponsor committee for their work pursuing Kent Cartridge Co as a potential sponsor. It may not work out but he was glad to see them working on it.

He also discussed a recent conversation he'd had with Omar. When he visited the Grand, Omar was really impressed with the way everything was brushed and hidden. And that is what he is stressing now. Make

sure when you set up tests you try use natural cover.

Secretary's Report - Elaine Mitchell

We met by phone or video conference and learned new ways of doing things. We didn't always know what we were doing but we figured it out. We got tests approved and posted... and then we canceled them! We faced things that HRC had never dealt with before; it was challenging but every decision right or wrong was made with one thought in mind. "Is it in the best interest of HRC?"

We are working hard to find ways to meet the demands of the growth that we are seeing. We all agree bringing youth into our organization is key to our continued growth. Technology is the key to that. We have to meet them where they live. We have got to find ways to modernize operations without excluding our less tech savvy members.

Elaine recognized Tammy Cobb for all her hard work as the new HRC Administrative Coordinator. They have a long list of things to work on for the upcoming year. Tammy already has a list of things for us to make this meeting better next year.

She announced that Ray Voight at Purina had contacted us regarding summer dog food shipments. Ray apologized profusely, but due to the retooling of one of their production lines, they would not be able to produce the Purina sample bags while the line was down. They hope to be back in production late August or early September and shipping as soon as possible. Clubs affected will be shipped boxes of dog treats in place of the normal sample bags.

VIII. NEW BUSINESS

Item #1 - Glenn Dye - Revival of the Lifetime Membership Committee

We used to have a committee to receive and present nominations for Honorary Lifetime Memberships. Over the years this committee has fallen by the wayside. At Omar's request, we'd like to re-energize that committee. Omar's health will not allow him to participate like he once did and Tracy Stubbs and Glen Stelly are the only other remaining former members. Omar asked that Tracy be appointed as Committee Chair and Glen Stelly to remain as a committee member. They have both agree to fill those roles. Glen Dye recognized Tracy to speak on behalf of the committee.

Honorary Membership Committee Report - Tracy Stubbs, Chairman

Tracy recounted his conversation with Omar about the committee and where Omar envisioned it going. They agreed that Glen Stelly would remain an active member of the committee. Mike Botts, Marcus Bice and Sarah Krause were appointed as new committee members.

Tracy then asked Glenn Dye to turn the meeting over to Jack Gravely, VP and leave the room. After Glenn's departure, Tracy reported that the first order of business for the newly revised committee was to submit a written nomination (copy attached) for Glenn Dye as an Honorary Lifetime Member. Glenn has served countless functions at the local level. On the national level he has served as Running Rules Rep for his region, the Field Rep for his region, 4 years as National Treasurer and 4 years as National President. On a personal level he lives and breathes HRC, his family and every function is oriented around HRC.

Item #2 - Margo Ellis-Lingohr - Double Staking for Judging Purposes Only

Margo made a motion to change policy to allow a person to double stake a dog "for judging purposes only". We have handlers that must forego running their dog in an upper stake in order to go back and run Started or Seasoned so that they can be eligible to judge. When you only get to run one or two events a year it is hard to convince people to make that sacrifice knowing when they do begin judging they are only going to giving up more and more opportunities to run and earn points on their dogs.

She reiterated, this would be ONLY for purposes of potential judges earning the required pass necessary to become a judge.

Call for questions/discussion:

<u>Glenn Dye, HRC President:</u> Just for a point of clarity, how would you monitor the individual has a real intent to become a judge.

Margo Ellis: We would still use the same process. They would have a club recommendation and all paperwork on file except the required points receipt. Once they have 1 pass in Started or Seasoned, they would no longer be eligible.

<u>Bill Ferrans, St Clair Flats HRC:</u> My question is, if you have a person that has never even run a Started dog, is that the right person to judge a Started test.

Margo Ellis-Lingohr: In our area we have a lot of people that are coming into the program. Very qualified judges in other venues, very qualified dog people understanding dog work. They come into our program with a Master dog, a Senior Dog etc. They immediately run finished and they have a finished pass on that dog. They enjoy the program and we approach them about judging. We just had this happen in Billings. We had a handler who has a Finished dog with Finished passes that gave up running his dog in Finished to attain the passes needed in lower stakes to judge.

Mike Botts, Mississippi Valley: There is a part of this organization that is giving your time, your energy. I was recently asked to judge in another venue. I have trained and judged at all levels in HRC but I still have to go through their apprenticeship program. I went through that process to help my club out. I think that is the process we need to keep in our organization.

Motion was made when presented by Margo. According to Joy Freeland, once debate begins, no second is required.

Item #3 - Tim Blan - Field Rep Approval of Started Judges

Made a motion to change policy to require Field Rep approval for an individual to begin apprenticeship at the Started level.

Motion seconded - Kim Olson, Prarie Lakes Retriever Club.

Discussion:

<u>Wayne Sumner, Northern Montezuma HRC</u>: As a Field Rep, when someone comes in and starts judging at Started, especially in a new club, we as Field Reps probably don't know them very well, if at all. I think the

club recommendation is enough to get them started. Then after several hunts I am in a better position as a Field Rep to make recommendations based on experience.

Ken Reinert, Key City HRC: In our Field Rep meeting we talked about getting involved more as teachers than policers. We want to get the clubs more involved. If the clubs can get them recruited to judges and get them in the judging pool and to seminars, even if we feel in the beginning they are a poor judges; that is where we are going to teach them to be better judges. It's up to the club to get them in there. It's up to the Field Reps to teach them what they need to know.

<u>Clayton Taylor, Central KY HRA:</u> I see the point in having a field rep approve that, but I would go a little further and say if you're going to do that, that we mandate that that started judge start in our region where we can take a look at them. Where we can get to know them. And we can maybe coach them up, as Ken said, as we're looking to do with a lot of these regional judges.

Result: Motion cannot be changed on the floor, it would have to be withdrawn and an amended version resubmitted or voted on as presented. The question was called as written and the result was a unanimous Nay – Motion failed.

Item #4 - Tim Blan - Field Rep Approval of Upland Judges

Tim made a motion to change policy to require Field Rep approval for an individual to begin apprenticeship for Upland Judges.

Motion Seconded – Ken Reinert – Muddy Waters HRC

Discussion: None

Result: Unanimous Nay – Motion failed.

Item #5 - Todd Tharp - Shoot ALL thrown birds

Motion to change policy on page 41 & 45 to read "During test simulations the handler must shoulder the shotgun, aim, track, shoot at the top of the arc of all thrown birds, including the diversion." The current policy reads "WHEN DIRECTED BY THE JUDGES, the handler must shoulder the gun, aim, track, and shoot at the top of the arc. We have had some clubs this year electing not to shoot the Walk-up and/or Diversion. The purpose of this policy change is simply to clarify that ALL thrown birds, including the walkup and diversion are to be shot by removing the words "WHEN DIRECTED BY THE JUDGES".

Motion Seconded - Bill Ferrans, St Clair Flats HRC.

Discussion:

After lengthy discussion the motion was amended to change the text from:

"During test simulations, when directed by the judges, the handler must shoulder the shotgun, aim, track, and shoot at the top of the arc of the thrown bird."

to: "During test simulations, the handler must shoulder the shotgun, aim, track, and shoot at the top of the arc of all thrown birds." On pages 41 and 45 of HRC Rulebook.

Motion seconded: Lisa Neel, Deer River HRC Result: 121 in favor, 1 opposed, – Motion Carried

Note: Todd returned to the podium after the break and advised that the same wording is included on page 36 and that it would be changed there as well. After the meeting had adjourned we consulted with Joy Freeland who confirmed that the official vote had only included pages 41 and 45 and that 36 would need to

be brought to the floor as a separate item at the next meeting.

Item #6 - Jessica Dowler, Dakota HRC - "Orange in Upland Hunts"

I am making a motion to add the following to the clothing policy: Clothing worn in upper hunt tests by judges, hunt marshals, gunners, handlers, and bird techs, must be blaze orange in colors suitable for upland hunting, including upper body: vest, jacket, or shirt; optional head covering: hat or visor. The justification is our current policy has no verbiage pertaining to upland hunt test clothing and this is a safety issue.

Motion Seconded – Marcus Bice, SOWEGA HRC

Discussion:

Glenda Mitchell, Lonesome Dove HRC: You said optional hat. I think that most state regulations require an orange hat.

<u>Jessica Dowler:</u> Most require square footage. This is a South Dakota club presenting this; one of the main reasons is that South Dakota has ZERO orange requirements for upland hunting.

<u>Bill Ferrans, St. Claire Flats:</u> I think it's a good idea. But, I think you would need to take into consideration the state that you're running. Some states require a number of inches. The handlers coming to that test need to know what to bring.

<u>Kim Olson, Mississippi Headwaters:</u> If everybody remembers, when we're doing the grand upland we require everybody in the field to wear orange. This is doing the same thing.

James Broetzmann, Wissill HRC: I am the upland training coordinator for my club. I've been doing that for four to five years now. And I require everybody there to have a hat and vest that's orange. And I also stress to my gunners that we, you know, we really stress gun safety in our regular hunt test. But here we actually use live rounds. And all it would take is one serious accident and that could put this all in jeopardy. I really do think we should have a policy for what has to be worn for upland training and testing.

Result: Unanimous Ayes, Motion Carried.

Item #7 - Riley Sandall - Test Setups for Handlers with disabilities

Riley presented the following proposal as submitted by a member of Roadrunner HRC. It is a policy change proposal regarding page 61, Rule 35, under Guidelines for Judges and Conducting Hunts. That begins on page 59 and index in the last page.

Current rule wording: Handlers with physical handicaps should advise the hunt secretary of their special needs prior to the hunt date. On hunt date the hunt committees and judges will make every reasonable effort to accommodate the needs of a handicap so they can enjoy and participate in all HRC slash UKC licensed hunts and tests.

The proposed change: All tests shall be set up to allow people with disabilities to fully participate. This includes providing solid footing at the running line and or walk-up pathways, reasonable accommodation to the test line, and other accommodations as may be required. Judges shall ask handlers at the handlers' assembly if anyone needs accommodations.

A person with a disability should notify the marshal and judges of any requests. Tests should be a reasonable blend of safety, accessibility, and realism. The hunt committee and judges will make reasonable efforts to accommodate the needs of people with disabilities during tests, test set-up, so they can enjoy

and participate in all HRC slash UKC licensed hunts and tests.

Justification: It's time to update the rules to provide reasonable accommodations to allow people with disabilities to fully participate. The way the rules are currently written it is the handler's responsibility to notify the hunt secretary in advance of the hunt of their special needs. This is backwards. The committee and judges should set up an accessible hunt in the first place. I have multiple health issues. I know many other handlers also have issues. I have driven thousands of miles to run my dog in hunt tests, only to find the test is not reasonably accessible. I have been tolerated to some extent, but I am often faced with a take it or leave it decision to risk my safety and run my dog. Requiring handlers to scramble up and down steep slopes, walk over precarious ground, slug through or stand in mud, sitting on flimsy buckets, or standing in unstable structures, should be avoided. The ability of a dog or handler team should not be hindered by a handler's disabilities. Setting up such tests needs to be phased out and the rules changed to encourage accessibility.

Motion Seconded: Randy McLean, Tennessee River HRC

Discussion:

Lane Blanchett, Middle Ga HRC: No disrespect to this proposed change but it's my belief that asking the handler in advance to notify the club just prepares the judges more to be able to set up a test that would be more reasonable for someone with some disability. If we wait till a handlers meeting to ask for that, it's pretty much after the fact and we're trying to react at the very last moment rather than being more prepared ahead of time.

<u>Chuck Prowler, Cherokee Foothills HRC</u>: Just a couple points. I've hunted with some veterans in Arkansas and rice fields. And they came to our club and told us we are handicapped. We need — we want to go hunting with you. We want to be able to get in the rice fields. We would have never known that we had to make preparations for them unless they came and talked to us. So it's kind of incumbent to them to prepare us to come out to our test. I think it would be incumbent upon a handler to let the club know that they're coming out to hunt with us. Our past tests we had, Cherokee Foothills down in South Carolina, we did have to deal with this. They came to us. It was incumbent to them to let us know they were handicapped and we need to make preparations to make their safe transit to the line a priority for us.

So I kind feel like it's upon the handler to let us know that they're handicapped. You know, we all want to be inclusive and everything and make the best possible experience for them, but we don't know what the handicaps are until they let us know. So that's kind of how I feel about that.

<u>Cathleen Karr, Kansas City HRC</u>: It is the case for our tests that we should be providing a safe line regardless, correct? You know, at our test sites, to take a look at safety as a club. I agree with the gentleman who was just up here that the handler's responsibility to let us know is very important because each need would be very specific to their situation.

<u>Glenn Dye</u>: Further discussion? No hands? Let's call the question. All those in favor of this policy as provided to us by Riley, signify by saying aye. Those opposed by saying nay.

Result: Unanimous Nays - Motion failed.

Item #8 – Jim Davis – Replacement of Judges Jackets

We would like to honor our long time judges who receive the tan judges jackets with updated camouflage jackets that they can proudly wear when judging. According to Tammy Cobb there are 145 current active judges who received the old style jackets. According to Sarah Krause, the HRC treasurer, the current price

of each jacket is approximately \$200, which would bring the maximum cost to HRC approximately \$29,000.

At this this time HRC assets are at \$568,246.53. We humbly request that the board of directors approve this to honor these judges who have continued to volunteer their time, knowledge, and expertise.

Motion Seconded: Leigh Jinks, Hurricane Lake

Discussion:

<u>Unknown:</u> What do we deem a long time judge?

Jim Davis: Long time judges are these judges were given these jackets 20 some years ago.

<u>Glenn Dye:</u> What we did was have Tammy pull a list of judges that had received a jacket from the beginning of the program until we started ordering the current style (camo) jacket. Then we condensed the list to those judges that were still currently active. That is how we determined the estimated cost.

<u>Jim Davis</u>: Correct. Not everyone that is eligible is going to request one. Some won't care. What we are asking is that those judges that only had the option to get the old style jacket be able to get the camo one so that they can actually wear it.

Marcus Bice: Jim already addressed it. If we are looking back 20 years; there are a lot of people that will never even ask for that jacket. So at the most it will cost us that but I bet it will be probably a third of that.

Glenn Dye: Yes, but the Board of Directors needs to look at the hardest hit. We COULD be hit with a \$29,000 bill. Just saying you all need to know that number before you make a decision on this.

<u>Lisa Neel:</u> We need to respect the judges that have been judging for years that got that tan jacket and give them the camo jacket that they can wear to the hunt test when they're judging. It's just a show of respect for their years of judging.

Result: Unanimous Ayes – Motion Carried.

With any further motions on the table, New Business was closed.

Nominating Committee Report and Election

Ray Caito reported for the Nominating Committee in the absence of Committee Chair Pat Johnson. The nominating committee presented the following nominations:

President: Jack Gravely, Bay Area HRC running unopposed.

Vice President: Glen Scarborough, Four States HRC and Don White, Midlands HRC.

Secretary: Elaine Mitchell, Midlands HRC running unopposed.

Treasurer: Caroline Davis, Central Florida HRC, running unopposed.

The nominees were fully vetted and met all the requirements to hold office for HRC. Each candidate was given the opportunity to address the group. Since they were unopposed, the offices of President, Secretary and Treasurer where approved by acclimation. The office of Vice President was voted on by written ballots. Glen Scarborough was elected Vice President. All officers' terms take effect immediately at the conclusion of the meeting.

With no further business to discuss, the meeting was adjourned.


