### April 22 and 23, 2023

Roadrunner HRC is pleased to hold our 2023 Hunt Test at Navajo Lake State Park, near Farmington, NM. The grounds are in the State Park along the San Juan River below Navajo Dam. The San Juan is a premier trout fishing river. Please be courteous to the numerous fishermen at the parking lots and along the paths. Pick up and dispose of trash, clean up after your dog and obey the park rules.

**A Day Use permit of \$5 is REQUIRED per vehicle per day and can be purchased in the parking lot at Simon Point during check in. Rangers will be looking for the sticker in the vehicle window.**

#### Directions from Farmington, NM

Take US-64 East thru Bloomfield. About 21 miles from Bloomfield and 2 miles past the town of Blanco, turn left onto NM-511. After 8 miles is the intersection with NM-173 (a Sinclair gas sign is at the corner), which is where the community of Navajo is located. Continue on NM-511 along the San Juan River. Simon Point Day Use Area is about 2 miles on the left. The turn off is marked.

Test sites we will use are listed in order of west to east: Crusher Hole, Simon Point, & Munoz
