Continue south about two miles – look for the Lilly Sand & Gravel Sign on the right. Turn north (right) into the Parking Area. GPS Coordinates (Latitude, Longitude 40.739107600, -98.568040900). <u>Check-in</u>: Check will begin at 7:00 AM. Handlers meeting will be at 7:30 AM. Test will begin promptly at 8:00 AM.

<u>Camping</u>: Windmill State Recreation Area is just north of the Gibbon I-80 Exit. The campground is operated by the Nebraska Game and Parks Commission (NGPC). Use the NGPC website to make reservations – (www.outdoomebraska.gov)
