#### **HUNT SCHEDULE & ENTRY FEES**

Tests start at 8:00 AM

Add \$5 for each entry for NON-UKC Registered Dogs.

Registration number MUST be provided.

Add \$5 for EACH Seasoned/Finished/Upland entry of dogs.

Whose owners are NOT HRC members.

Add \$10 late entry fee for each entry after January 27th, 2026 deadline.

Day of dog swaps (1-for-1) will be assessed a \$40 administrative fee for each dog swapped in addition to the \$10 late entry fee.

#### **COURSES**

Chukars will be used in all Hunts.

Clothing worn in retrieving hunt tests by judges, hunt marshals, gunners and handlers must be full camouflage per the Clothing Policy stated in the current HRC Rulebook. Orange Hat and Vest are Required for Upland Hunts.

Scratches require a veterinarian's certificate (Illness, Injury or Bitch in Season). Scratches prior to the advance closing date will be refunded by HuntSecretary.com. Scratches after that date will receive a full refund WHEN CERTIFIED BY A VETERINARIAN. NO ACTION will be taken until the Hunt Secretary receives a written notice (dogs name, tests entered, whom to make check payable to, and written vet excuse on clinic letterhead, signed by veterinarian). This written request must be received within 5 days of the completion of the test. Approved scratches after the closing date will be assessed a \$5 administrative fee per dog.

Refunds WILL NOT be issued for no-shows.
