### **SCRATCHES**

Scratches prior to closing date will be refunded by HuntSecretary.com. After the closing date, all scratches will be handled based on the Club Scratch Policy specified below.

#### **Club Scratch Policy**

Prior to close, you can scratch a dog for any reason and receive a refund (less the Administrative fee) from [www.HuntSecretary.com](http://www.HuntSecretary.com) After the closing date, all scratches will be handled based on the Club Policy stated here. Full refunds shall be given for any scratch prior to the early entry date. The scratch after the closing of the early entry policy shall be as follows: full refund will be given for female dogs in heat, for injury, illness, or death, when certified by a veterinarian. No action will be taken until the Hunt Test Secretary receives a written request including dogs name, test(s) entered, whom to make the check payable to, address to mail refund, written vet excuse on clinic letterhead and signed by the vet. No refunds for no shows. Female dogs in heat shall not be allowed to enter or participate in the hunt test(s). The club shall follow the standard set forth by the UKC/HRC regarding female dogs in heat with the following club revisions:

1. All females suspected of being in heat during the day of the event shall be checked on site by the club appointed committee member or on-site vet technician.
2. If a female is found to be in heat during the event, checked and verified by the appointed club committee member or on-site vet technician and PRIOR to running, the dog shall not be allowed to participate any further. All entries and fees for that dog shall be refunded.
3. If a female is found to be in heat during the event, checked and verified by the appointed club committee member or on-site vet technician and AFTER running any part of the test, the dog shall not be allowed to participate any further. All entries and fees for that dog shall be forfeited.
