Scratches prior to closing date will be refunded by HuntSecretary.com.

After the closing date, all scratches will be handled based on the Club Scratch Policy:

All scratches must be reported in writing to the Hunt Secretary as early as possible. Scratches not reported prior to 7:30 am on test day will be considered no-shows. Dogs may be scratched due to bitches being in season, illness, injury, or death. The Hunt Test Committee reserves the right to require veterinarian certificates. Requests for refunds, stating the reason for scratching, must be submitted to the Test Secretary by postal mail or email within seven (7) days after the conclusion of the hunt. No refunds for no-shows. Refunds will be in the amount of the registration fee less a \$15.00 administrative fee.
